Rental Agreement Contract

AQua Wave Swim School shall be available for use by the public on a reservation basis subject to the conditions outlined below. The purpose of these guidelines is to establish standard procedures for administering the policy and to insure fairness in the letting of the facility.

The applicant granted the reservation agrees to read and abide by the following:

1. User agrees to indemnify and hold harmless AQua Wave Swim School, its agents, and employees from and against any claims for damages to persons or property arising out of any use of AQua Wave and its premises by User. AQua Wave Swim School assumes no responsibility for any property placed in or about AQua Wave.
2. No oral agreement for the use of AQua Wave Swim School shall be valid. All reservations must be confirmed with a written contract, signed and approved by AQua Wave Swim School. Any changes to the guest list or the number of party participants must be finalized (4) four days prior to the party.
3. The fees for parties are as follows:

1-9 Children / 1 Adult Lifeguard	\$400.00 for 2 hour party	\$450.00 for 2 hour party
10-18 Children / 2 Adult Lifeguards	\$450.00 for 2 hour party	\$500.00 for 2 hour party
19-27 Children / 3 Adult Lifeguards	\$500.00 for 2 hour party	\$550.00 for 2 hour party

\$75.00 non-refundable deposit is required to reserve the party date

4. Party policy requires that the swim time is to be utilized first, followed by the deck time (i.e. cake and presents). The pool will be covered during deck time. All deck activities and/or games must be pre- approved and finalized by an AQua Wave manager (4) four days in advanced of the party.
5. User is responsible for the set up and clean up of the facility. Set up time is 15 minutes prior to the party. The User should not attempt to gain access to the function room prior to this time. Clean up time shall last 15 minutes after the reserved party time. User agrees to leave the premises in as good or better condition than which existed prior to their usage. All trash must be disposed of properly. All decorations must be removed. No confetti is allowed in the pool area.
6. AQua Wave Swim School will provide pool toys. Any other toys must be pre-approved by AQua Wave Swim School.
7. **No glass containers or ceramic containers.** AQua Wave Swim School shall not permit alcoholic beverages on its premises or in the area surrounding the facility. **SMOKING IS NOT PERMITTED ANYWHERE ON THE PREMISES.**
8. Management reserves the right to stop or cancel a party at any time.
9. For every 15 minutes the party goes over; there is a \$50.00 fee.

NOTE: All of the above rules and regulations are subject to change at any time.
